This is our attempt to exercise our 10th Concept rights as members of Narcotics Anonymous. There are several issues which are troubling to us. They are as follows:

- 1. The addition of 10 stories to the 6th edition of the basic text without following the previously agreed upon approval process.
- 2. The addition of World Board opinion without a contrasting opinion on the CAR.
- 3. The difficulty with motions stemming from the tendency of the World Board to discourage motions from the fellowship.

To preface our reasoning, you are to be complimented on the quality of written materials created to help our individual members and fellowship recover, grow and develop over time. The emphasis on service materials is excellent and significantly helpful to us. Your efforts on behalf of a diversity concept are exemplary. Your responses to individual requests for clarification and help are, on the whole, outstanding. People know that in these ways, our trusted servants are quite responsive, prompt and thorough. The problem, as we see it, is in an underlying belief system first seen in the 1999 World Board Report. This is where the World Board begins a drift away from functioning according to our 12 Traditions and 12 Concepts. This is very sad. As we began researching to understand the dilemma at a depth deep enough to suggest solutions, it became obvious that the Board was itself seeking solutions to a chaotic work environment and inefficient manner of completing tasks. At that point, the tasks remained those of *trusted servants*. Somehow, over the intervening years this has translated into *leaders* and *leadership*.

As our guide to this problem solving, we used the *Basic Text, It Works, How and Why*, and the *Twelve Concepts for NA Service*. In the BT, under Tradition Two, there is a concept which is guiding our approach to you. "True spiritual principles are never in conflict; they complement each other. The spiritual conscience of a group will never contradict any of our Traditions" (BT, page 61).

Throughout our traditions, the idea that there is a difference between leadership in the world outside of NA and leadership as a trusted servant inside NA becomes evident. While we could belabor the point and send you pages of quotes supporting this grievance; this is unnecessary. Besides, the problem seems to lie in more subtle elements of the relationship between the fellowship and the World Board. It is our hope that this formal grievance approach will cause you to self examine in the NA manner we have found necessary to write this to you.

Our request is for a living amends. We want you to locate within yourselves and your structure, the attitudes and ideas that made it acceptable to you to move from trusted servants to leaders of the fellowship. You don't even need to inform us of the outcome of such self searching. What we want is a change in behavior, the kind of change that only takes place after effective soul searching.

You do important work and we need you to continue doing such work. We simply want you to remember that ours is a bottom up fellowship, not a top down one. Decisions flow from the individual member upward. Leadership for you comes from us, not from you to us.

Thank you in advance for reading and thinking about this in the thorough and thoughtful manner in which it has been written. Sincerely,

Question – What we are discussing is taking this back to our Areas and Home

groups to decide if we want to send this to the World as a Region? Answer – Yes.

Con to the motion – The World Board is trying to get information to the fellowship to the best of their ability.

Question – Would it be beneficial to have a WSC inventory, since we have inventory's at all the other levels?

Question – Didn't we already approve the 6th edition Basic Text? Why are we discussing this now?

Answer – The motion is not intended to ask them to change what's done, but any literature read in our meetings is fellowship approved, not board approved. We are just asking them to review their practices in the future. We have a process for literature review and they should stick to it.

Comment – According to the WSO, the Regional Delegates instructed the World Board to place their recommendation on the Conference Agenda Report (CAR) so they would know how the World Board stands on motions.

Question posed to World Board – "Why not have 2 pros and 2 cons?" Answer from World Board – "The Region places their intent and rationale on the motion so the World Board places their recommendation on the motion as well."

Comment – Our website was down for a handful of days because our website has been in an individual member's name and for whatever reason, the payment was not made. This should be taken care of by the Region, however, the website will only take payment via credit/debit card. In order to get the website going again, the payment and website was put on our Treasurer's personal credit card. We, as a Region, need to take care of our own affairs.

Comment – At any given time, the Treasurer has access to thousands of dollars. We elect them as a trusted servant. Rotation provides "a diversity of viewpoints and talents and a freshness of perspective that would lacking were these positions to be held year after year by the same individuals (p. 50)."

"The practice of rotation is founded on this fellowship's belief that service is more important than the servant, an extension of our tradition of spiritual anonymity (p. 51)." reasons. By periodically replacing delegates, the region is assured of being provided with varying views of world service affairs.
