# **RCM Report-**

 The VRSC meeting was held Feb. 3, 2008 in Nashville at the A & D Council Meeting, the meeting was opened in the usual fashion with the serenity prayer, the service prayer, the reading of The Twelve Concepts of Service, The Twelve Traditions of Narcotics Anonymous, and the VRSC Purpose.

- Administrative Committee members present were Vice Chair, Secretary, and
  Treasurer. The following Administrative Committee positions are currently vacant:
  Chair, Alternate Secretary, and Alternate Treasurer. The VRSC Regional Delegate was
  present; currently the Regional Delegate Alternate position is vacant. PI, Outreach,
  VRC XXV, VRC XXVI, and VRCGRC (ad hoc) sub-committees were represented.
  Activities, H & I, Literature, and Policy and Procedure sub-committee chair positions
  are all vacant at this time.
- 10 out of 11 Areas were represented and a quorum was established.
- The Secretary's Report was presented; he reported that some complaints were received concerning the legibility of some of the scanned documents from the previous VRSC minutes. He reminded us that his contact info is on the Regional Contact list and is available if any one has problems with scanned documents in the future. He has also re-organized the Regional Archive box and in the process, located the Regional Adhoc Committee report with the suggested rotation for the Regional Inventory. It is as follows:
  - 1. Upper Cumberland Area (2006)
  - 2. Central Tennessee Area (2007)
  - 3. West Tennessee Area (2008)
  - 4. Mountain Area (2009)
  - 5. Southern Middle Area (2010)
  - 6. Chattanooga Area (2011)
  - 7. Middle Tennessee Area (2012)
  - 8. Greater Smokey Mountain Area (2013)
  - 9. Greater Nashville Area (2014)
  - He also spoke on the CAT (Conference Agenda Track) Report, this report is available online and for all those interested let me know and I'll give info on accessing it.

- The Treasurer presented her report; the bank balance as of 2-2-08 was \$13,860.65. New budgets from subcommittees are due in July. She clarified the hotel reimbursement guideline, \$75.00 or 50% whichever is less. She also clarified VRC seed money on Profit and Loss Statement; it does not show up on P & L Fiscal Year to Date Statement because these funds are typically disbursed in Feb.
- Group Reports were then presented.

- The Regional Delegate presented her report. She attended an event in Maine, the MRLE where she gathered more information regarding CAR. She also spoke about the CAR workshops to be held throughout the region, and requested information about each area from the RCMs. The information requested was about the number of groups and meetings and also about H & I meetings and number of facilities we had meetings in. She also reminded us about the CAT report as well.
- The Vice-Chair presented his report. He clarified the voting process and how it appears in the VRSC minutes. Not all motions require a vote from the RCMs to be sent back to the areas, only those changing or amending guidelines of the VRSC are required to be voted on by RCMs, everything else is automatically returned to the areas for their Group Conscience. He also clarified the terms of the Sub-committee Chairs; they are elected in December and take office in Feb. VRSC officers are elected in June. He stated his intention to submit a motion to have a regional inventory, and referred to key points identified at the last regional inventory held Jan. 28<sup>th</sup> and 29<sup>th</sup> of 2006. They are as follows:
  - 1) Apathy in service
  - 2) Communication between service bodies
  - 3) Being diverted from our primary purpose due to money, property, and prestige
  - 4) Using group autonomy to negatively affect other groups and NA as a whole
  - 5) No credibility in Region due to lack of service
  - 6) Discrimination,
  - 7) Inability to be a resource to groups and areas,
  - 8) Outside issues affecting clarity of NA message,
  - 9) VRC, does it carry our primary purpose pr divert us from it,
  - 10) Lack of unity.

#### **Sub-Committee Reports**

- H & I met on Feb. 2 with 14 members in attendance representing 6 areas. There is a nomination pending for and H & I Regional Chair. The areas gave reports on the facilities they were currently conducting meetings in, those that had requested meetings, their financial and literature needs.
- PI gave reports from various regions regarding their efforts and events that had been planned. They also reported on the PI vs. PR handbook and the World's response to their request to make the PI guide available. The were basically told to adapt to the new literature, but they were free to use either one at their discretion. The voted as a sub-committee to use both books.
- Webmaster presented his report with statistics regarding most popular pages, and where the traffic originated from. The third most popular entry to the site was via naknoxville.org.
- Outreach reported being asked to facilitate two Learning Days/Workshops for two different areas in the previous two months. Several other areas have requested other workshops and learning days to be held in the near future as well.

- VRC XXV presented their final report along with a check for \$13,935.40 to the VRSC treasurer. Details of registration, merchandise, and events were also presented.
- VRCXXVI reported they had a committee started, their regularly scheduled meeting time. They also reported there were still some open positions on their subcommittee. They have pre-convention flyers and were having their first mailing in February.
- VRCGRC (ad-hoc) presented the new guidelines that were a result of their 15 months
  of review and revisions of the current VRC guidelines. They have also produced a
  workbook for negotiating with hotels. The chairperson related many issues and
  concerns regarding how the convention is not only conducted, but also how it is
  funded. His report is very informative and also quite lengthy. It as well as the
  proposed guidelines are available for review on the Regional Website along with the
  rest of the Regional Minutes.
- As part of the Sales Tax ad-hoc sub-committee, two addicts made a presentation to the Department of Revenues Audit Division, they presented information and literature and explained the history pf NA to the Director and Associate Director of the Audit Division. Questions regarding literature and sales tax were raised during this session, in the course of the discussion the director suggested that the terms sell and required donation should not be used when describing the distribution of our literature. The director told the addicts that upon initial inspection we did not appear to be in violation of Tennessee Tax law, however the director was going to discuss the situation with all the Department Directors to make certain there were no other possible issues.
- Area Concerns were then discussed.
