The region met in Nashville, with eight areas represented. Here is the short version of what happened and what's coming up. This report is but a summary. The regional minutes were contained in 43 pages. I hope to have the full version of the minutes on posted on our new web site.

VR\$C Treasurer's Report – The current balance is \$5476.71. The profit loss and year to date reports are attached. The audit of our financial records by a paid professional has been completed. Reports are attached.

Area Reports

Central TN – They that the phone line is up and running. The number is 866-897-2862. They have all new trusted servants and have a PI learning day planned.

Chattanooga – They have added another H&I meeting in the Walker County Prison. (two per week) They report that the Cadas, Scholtze, Focus, Bradley and Valley institution meetings are going well and that there is meeting in the Hamilton County jail that needs more support. They are having a CAR workshop on March 3.

Greater Nashville – They report that things are getting better. They recently held an area inventory that allowed them to look at things that were working and some things that were not. The annual KISS campout is scheduled for May 5th, 6th and 7th. Registration forms are available on NA.org.

Middle TN. – The area is in need of help. Alt. RCM, Outreach, Policy & Procedure, and alt Secretary are open. They had an area inventory February 11.

Mountain – They thanked the Regional Outreach committee for assisting with their recent area inventory. They came up with some solutions to ongoing problems. They have 13 groups with 29 meetings a week. Fie H&I meetings in 5 facilities. They held an H&I orientation at the last H&I meeting. They now have a PI subcommittee. Connie S is the area PI chair. Their newly formed Outreach subcommittee just got their guidelines approved.

Southern Middle TN – The area is doing ok. H&I is struggling for participation. A jail in Lewisburg is willing to let them back in at this time. They are looking for more participation at the area.

Twin Lakes Area:

This is a new area formed about two months ago. They have 10 groups. All service positions filled. The area meets the 2nd Sunday of each month a 3:00 pm at St. Michaels Church – Cookeville.

Upper Cumberland – They recently hosted the Regional inventory and had good participation. Planning a PI learning day in March. H&I and PI continue to spread the message.

West TN - CAR workshop scheduled for February

Ad Hoc Regional Inventory Planning Subcommittee

The Regional inventory was held in Crossville January 28 and 29. There were many problems brought to light. The subcommittee was asked to continue and try to come with a plan to implement some of the suggested solutions that follow. Here were some of suggested problems and solutions:

Problems:

- Some meetings don't have an NA message
- Meetings bringing in outside literature
- Reports from region not getting back to areas/groups/individual members
- Areas using the resources of other areas or the region instead of being supporting themselves
- Trusted Servants not following through with commitments
- Being diverted from our primary purpose by concerns of money, property and prestige

Solutions:

- Create Tradition workshops
- Have Service Learning Days
- Get service committees running
- Sponsorship and mentorship (be an example to others)
- Workshops and training sessions for new trusted servants
- Every area should have own phoneline
- Regional outreach is reaching out into counties that don't have groups and helping area conduct inventories
- Focus on sharing information between areas and have meeting schedules available to share with other areas.
- Review and rewrite area policies as if needed.
- Back up what is said and done by the traditions, concepts, guidebooks and policies.
- Steady, progressive forward moving changes. Be practical and don't overload.
- Have a board of directors to OK final decisions made in the VRC sub-committee.
- Send funds from area fundraisers directly to the regional service committee
- Have area subs-committee chairs attend the regional meeting,
- Make a determination each year to see if the convention is feasible.

Problem:

- Using unapproved literature at meetings
- Using group autonomy to negatively affect other groups or NA as a whole

Solutions:

- Being knowledgeable of approved literature and stand on principle
- Uphold traditions no matter what.
- Ask the person to leave and be prepared to escort out if they leave no other alternative.
- Get a group together to go to the meeting
- Educate chair people in other meetings
- Each person goes back and starts a tradition study in their area.

Outreach subcommittee

Outreach has been busy helping area conduct their area inventories. They have been in contact with several areas that are interested in forming their own outreach subcommittees. We have picked up 12 new counties with NA meetings in the last 6 months. Wer'e up to 176 groups in 53 counties in the state. They ask us to let them know our needs and they will go to any lengths to help us carry our message.



GROUPS TO VOTE ON THE FOLLOWING CAR MOTIONS:



Motion 1: To direct the World Board to develop a project plan, timeline, and budget for WSC 2008, to create/develop a glossary of recovery terms typically used in Narcotics Anonymous

Intent: To provide a resource of common meanings for frequently used NA recovery terms.

Maker: Northern New York Region

Financial Impact: The financial impact would be whatever time it took the World Board to have the necessary discussions to frame this project plan for presentation to the conference and for the conference to consider the proposal. The cost of any potential project would depend on the details of the project plan.

Policy Affected: None.

Rationale by Region: It is the belief of this area that a need has arisen to create a glossary of recovery related terms. While many of these words can be found in a dictionary, some of these definitions may not reflect recovery, also the recovery terms used in the fellowship are not found in dictionaries. A sponsor is a tool for addicts to use to gain an understanding of recovery terms, but it is the belief or our group conscience that a glossary will be extremely beneficial to the sponsor/sponsee relationship. A glossary of terms may also help newcomers, who we, as experienced members, need to take "a special interest in a confused addict who wants to stop using." When created, it will provide a resource for addicts and promote a common understanding of recovery terms. This will further enhance unity in the fellowship, instead of allowing different meaning of words separate addicts.

World Board: *Our recommendation is not to adopt.* We are concerned about the intent of this motion which seems to want to create an "official" definition for a variety of NA language. We fear that these sorts of "official" definitions and attempts to standardize understandings of our principles may encourage a

dogmatic attitude or an inflexible understanding. Many of our words and phrases are open to interpretation by their very nature. We do not think an attempt to define, dictionary-style, "surrender" or "conscious contact," for instance, would be either practical or helpful.

Even were we in favor of this idea, however, in our current system making a motion in the *Conference Agenda Report* is not the best way to get work considered. Talking with or writing to the board is one way to initiate a conversation with us about an idea. Attending a world services event or an event that world services is participating in also provides an opportunity to have a conversation both with NAWS and with other regions about the idea. The *Conference Reports* and the online bulletin boards also offer a forum for regions that have ideas they want to discuss with other regions. The board takes all of these interactions with the fellowship into consideration when planning for the upcoming cycle. We draft project plans for conference consideration according to the overall strategic approach that has been directing our efforts since the restructuring of world services. We would ask that the conference let us take the idea of a glossary under consideration when framing project plans for the next conference, but we do not recommend mandating the creation of a formal project plan.



Motion 2: To direct the World Board to create a project plan for the development of a fellowship-approved Identity Statement to be presented at WSC 2008.

Intent: To obtain literature that will recognize the distinguishing characteristics of the Narcotics Anonymous fellowship from other twelve-step fellowships.

Maker: Ohio Region

Financial Impact: The financial impact would be whatever time it took the World Board to have the necessary discussions to frame this project plan for presentation to the conference and for the conference to consider the proposal. The cost of any potential project would depend on the details of the project plan.

Policy Affected: None.

Rationale by Region: There are currently in existence several different versions of an Identity Statement that circulate throughout the Narcotics Anonymous Fellowship. Many home groups have chosen to make them part of their group readings. Additionally, they are read at several Area and Regional conventions, and even some service committees have chosen to include them as part of their reading materials.

Although they are unofficial in nature, these statements have gained wide support from the fellowship. They have been embraced for the simple reason that no such fellowship-approved literature is available. Therefore, addicts have been left to the vices of developing literature for themselves.

We believe that our fellowship would be better served if there were available a single fellowship-approved Identity Statement. This would provide a means of having a message that is consistent and would alleviate many of the problems associated with the many unofficial statements currently in circulation.

World Board: *Our recommendation is not to adopt.* While we do understand that some groups include an identity statement of some kind in their meeting format because they feel that such a statement helps to clarify the language and program of NA, we do not feel it is necessary to have such a statement become the focus of a world services project. Groups who choose to use a clarity or identity statement are, of course, free to do so; the principle of group autonomy ensures that. To develop such a statement on a world level, however, could imply that all groups should read such a statement, an implication we do not support.

Motion 3: To change the time frame for approval form recovery literature from the current minimum of 150 days to a minimum of one year.

Intent: To extend the time frame for approval form literature to allow sufficient time to communities who choose to make a rough translation.

Maker: German Speaking Region

Financial Impact: There is no direct financial impact as a result of this motion. Policy Affected: This action would directly amend the following WSC policies:

Page 32, Approval Process for Recovery Literature

B. Approval-form Literature

1. Approval-form literature is prepared by the World Board and is distributed for a period of time, considering translations, determined by the World Board of not less than one hundred fifty (150) days one year. The length of this approval period is determined by the World Board based on the needs of the fellowship and the piece being considered for approval.

Rationale by Region: New literature is presented in English. Thus it is not accessible to large parts of our fellowship. To reach an informed group conscience, literature has to be available in our language as a rough draft translation. To do this, we need at least 6 month time ADDITIONAL to the usual approval period.

Timelines of 6–9 months for recent projects appear to be enough time for the whole process of reaching an informed group conscience—under the condition, that members are able to read the language in which it is written! Obviously, this procedure is not possible for us as a non-English-speaking fellowship—without having a rough translation draft available.

For any substantial piece of literature, 12 months would still be extremely short! But approving this motion would at least be a step towards giving us and any other non-English-speaking Region an equal chance to participate in the literature approval process.

World Board: *Our recommendation is to not adopt.* We continue to believe that we need to become more responsive yet efficient in literature development. Extending the approval period for literature projects could result in a longer development period for the project as a whole, thus turning a one-cycle project into a two-cycle project, or it would collapse the amount of time available for other parts of the project such as review and input. And with a

mandated minimum, the extended approval period would apply across the board—to IPs as well as books. Our experience with the Sponsorship Book, which was effectively out for nine months in approval form, did not indicate that extending the time period made the book become more of a priority for translation committees or more subject to fellowship-wide review. What's more, while many if not most translation committees know this, it bears repeating here nonetheless: Other language communities can choose whether or not to translate any given piece of English-language literature. That is, if a 2006 *CAR* 37

given piece of literature does not meet a community's needs, they do not have to translate it.

Determining whether to approve a piece of literature or not is one small part of the development process. The last literature project, the *Sponsorship* book, and the current project, the Basic Text revision, both depend on participation from members around the world for their success. Contributing material toward a literature project or giving input on it allows much more influence on NA recovery literature than a yes or no vote on a piece, and participation at this level has been accessible to any community for the past two projects.

GSMASC Treasurer Report

Hello Fellow Members,

Our current balance is \$3,889.55. This is \$1359.55 above our prudent reserve.

We have been very fortunate lately in regard to our income versus our expenses. If this month's donations are as generous we will be making another healthy contribution to the Region in April. If you recall, we donated \$1026.78 last month. My point in mentioning this is the excess we currently have above our prudent reserve. The donation being made in April will be shown as an expense next month. This will bring our balance down near our prudent reserve.

On the Income/Expense report please note a "Reconciled" entry for \$83.71. As I have previously stated, our accounting report was not in line with our bank statement. This reconciled amount balances our records with the bank. I finally felt comfortable in doing this based on the work David and I have been

doing on the audit. While there is still the potential for a difference between our bank statement and the Treasurer's Report this is due to all the financial transactions not clearing the bank from the previous month's business. This month I was fortunate the Transaction History, which is included, had all our checks from last month cleared. This helped me see that the reconciled amount mentioned above was correct.

Last month I turned over the key to our PO Box to the Vice-Chair (since he lives and works in Knoxville) so that he could start getting the mail and look over the Bank Statement before turning it over to me. I truly believe this to be a healthy practice: one that will help to maintain the integrity of the Treasurer by providing the means which someone else can see what is transpiring with our finances.

As stated last month, I have started using a report generated from the Quicken software that I use for maintaining our financial records to show Income and Expenses (what others refer to as Profit and Loss). This is somewhat different than what you are use to seeing. So, if you have any questions please ask. One thing about this report is that it does <u>not</u> show the beginning and ending balance, only the income and expenditures. By using reports generated from accounting software it reduces the risk of mistakes with our records because it does all the calculations. It also keeps all our records in one place that can be turned over on a regular basis to Administrative members for easy review. I do not want anyone to ever have to go through what I have while performing an audit again.

Speaking of the audit, we canceled that this past month due to the weather. Since I do not own a crystal ball, I could not know how bad the snow, and roads, were going to get on the day we were to meet. This has not been dropped, the information will be coming as soon as we can reschedule.

We had a subcommittee meeting Feb. 8. The subcommittee meeting minutes are now posted on the website. There were many topics covered, and I will discuss some of the important topics below. Overall, the website is coming along well and many have expressed their approval. The topic of guidelines for the Website Subcommittee was discussed, and our thought was to use Chapter 10 "Internet Technology" from the Public Relations Handbook as the subcommittee's guidelines, taking advantage of the work already being done by World. However, the Public Relations Handbook is not yet conference-approved literature, so perhaps we can't yet use that. In any case, a Group would have to make a motion to add this to the Bylaws.

Pro: Outreach will cut out hearsay about a meeting. If properly done, it is a great tool for service.


Pro: Some smaller meetings that are struggling could get support/knowledge from Outreach.
