<u>Literature – Jackie G:</u>

Hey Family,

The June 2006 order left us a credit balance of \$782.62 with Show Me RSO. The July 11, 2006 order totaled \$1045.19, which leaves us owing SMRSO \$262.55. Of this shortage, \$107.10 was due to the fact that the first order I placed was missing a box of literature that arrived a week later. When I received the box, it was damaged and was missing 60 of the Introductory Guides to NA. By the time I spoke with SMRSO about the damage and shortage, the box had been discarded along with the tracking number so a claim could not be filed. In addition to this, \$155.45 of the shortage was due to over ordering on June's order to replace the shortage of the Introductory Guides.

Solution-As a subcommittee of the Area, we can not make a motion; the subcommittee needs a home group to make a motion to the area to pay SMRSO the balance due of \$262.55.
