#### Regional Delegate Report

The RD and RDA attended the World Service Conference in Woodland Hills CA April 23-29.

#### **Narcotics Anonymous World Service Summary**

NA is spoken in 65 languages but only printed in 25. Everything that's translated must then be translated back into English to ensure that the concept was not lost. During the last two years 55 pieces of literature have been translated. It is a long process.

**World Pool** There are 788 members in the world pool 174 non-US members and 614 US members. The world pool is a collection of people just like us who have volunteered their time to work on projects for NA. Anyone can submit a world pool form to offer his or her services.

#### **IRAN**

Several years ago the first NA convention was held in IRAN. There were over 25,000 members with 2500 meetings in the country. Men with clean time sometimes are sponsoring 125 men. In eight months 51,000 basic texts and 1.1 million IPs were distributed. Now there are 4500 meetings and 50,000 members.

The RD spoke to NAWS about the issue of the using unapproved material in meetings within the Smoky Mountain Area. The response was that the understanding fellowship wide is that the 5<sup>th</sup> edition of the basic text and conference-approved material are the only things that should be read at meetings.

#### **Greater Smoky Mountain Area:**

We are moving in the Greater Smoky Mountain Area of Narcotics Anonymous. We completed our area inventory a couple of months ago and now have formed an adhoc subcommittee to offer a revised set of guidelines to address some of the issues that arose from the inventory. Personally, I see some stormy days ahead but we're making progress.

We just elected a new PI chair. As one of his first acts he came to the Regional PI subcommittee meeting to get and give support. I'm sure the first PI subcommittee to be held in Knoxville in a long time will be announced very shortly.

Our local NA website is up and running with new content being added every week. Our meeting schedule is available there. www.knoxvillena.org.

We also recently elected an activities subcommittee chair. We are staring the planning for area events whose purpose is solely to foster unity versus raising funds.

The Recovery On The Ridge (ROR) subcommittee is going well. They are still ahead of their fund raising goals and are working closely with the new activities subcommittee and the area groups to coordinate events.

The new literature chair and subcommittee are functioning well. There is actually a functioning subcommittee with volunteers that show up to help count and distribute literature.

The Hospitals and Institutions Subcommittee had another productive meeting prior to the June 24 meeting of area. Two new panel leaders were elected - James W. for the Anderson County Jail Men's meeting and Anthony B. for the Gateway meeting. Jeremy E., who is stepping down as Gateway panel leader, will continue to serve as the subcommittee's secretary. The most recent panel added to the subcommittee, for the Detox ward at Center Pointe, is up and running, and a vote was passed to combine the literature order for the Detox and Inpatient panels. The literature order for May was slightly more than \$297, and for June that figure was a little more than \$396 (the difference is due to the fact that literature shortage in May meant we were unable to receive everything we requested). As always, the subcommittee needs the support of NA members to continue carrying the message to those who can't get out to meetings on a regular basis. Anderson County Jail is not not accepting new applications for the men's or women's meetings, but Knox County Detention Facility has been in need of support for some time. Greg V. and Jason S. have applications for those who wish to apply to carry the message to Knox County inmates. In addition, the Greater Smoky Mountain Area has been asked to support a prison meeting in Bledsoe County. The inmates hold their own meeting, so it would not be an H&I panel, per se; this county is on the fringe of three different areas but is a member of none, and jail officials would like some outside recovering addicts to support the meeting.
