Hello Fellow Members,

Our current balance is \$3,320.62. This is after the donation that we will be making to the Region in the amount of \$1,059.55: leaving us with a balance of \$790.62 above our prudent reserve.

I hope you will overlook my not having a Transaction History at today's meeting. Due to my work schedule, I was unable to get that printout from the bank. If I can make our deposit tomorrow I will get the

report then and email it to our Secretary so that it can be included in the minutes. Remember that when you see this history it will not have the donation to the Region; thereby, it will be that much greater than the above stated balance.

I have spoke with both Mike and James about presenting the audit information at the follow-up Area Inventory meeting. They both agreed that would be a good time for this to take place. I would like to do this an hour before the scheduled time for the inventory so as not to take away from it. This will be a presentation of information. From this I hope that it will bring about a better understanding of why I have suggested and implemented some of the changes that I have made in the way the Treasurer conducts their business.

Speaking of the way the Treasurer conducts their business. If there are no objections, I will be purchasing a copy of Quicken for our Alternate Treasurer so that he has time to learn and start working with this software. The cost for this software will be approximately \$50.00. I will be searching to find the best price possible from a reputable distributor.

At our last two ASC Meetings, during open forum, the question was asked about the appropriateness of collecting a 7th Tradition during the business meeting. At the suggestion of an area member I email NAWS with that question. (Please see the attachment with our exchange of emails.) Based on this information I recommend that we stop passing the basket during our service committee meetings. For a better understanding of this I suggest studying our 7th Tradition and our 11th Concept (I know that I will be revisiting this material in our literature).

Pass The Basket During Service Meetings

During open discussion the previous two months a question was asked concerning the appropriateness of collecting the 7th Tradition during the ASC Meeting. I stated that I would do some investigating. I had the following exchange of emails to a NAWS staff member. I then followed this up with some reading of 11th Concept and the 7th Tradition from the "Basic Text" and "It Works How and Why."

An interesting question was asked at a recent ASC meeting, "Is it appropriate to pass the 7th Tradition Basket during the ASC meeting?"

I am unaware of any information concerning this. Your help would be appreciated.

Here is the response.

Dear Ken:

Thank you for the email communiqué and request for information regarding the Seventh Tradition and passing the basket at an area meeting. We know of and have heard when subcommittees meet they at times take a collection simply to pay for refreshments or what have you but don't refer to the collection as the Seventh Tradition because they feel that the Seventh Tradition is for the groups, and a subcommittee or service committee is not a group. The groups are theoretical support the service structure through their Seventh Tradition contributions.

Not to say that it hasn't happened or is happening at this moment, however, to the best of my knowledge NA World Services has never been apprised that ASC's are observing the Seventh Tradition during their business meeting. The only mention of funding in the guiding principles for the service structure, the *Twelve Concepts for NA Service*,

is found in Concept Eleven which basically states what was listed earlier in this communiqué, that NA members (via the Seventh Tradition practiced in their groups) contribute money to help the fellowship fulfill its primary purpose.

With all that's said, one might ask why is the ASC passing the basket during the business meeting? Maybe there's a valid reason, we don't know; but to alleviate any confusion or controversy, if they chose to continue passing the basket they may want to consider making an announcement, in some form or fashion, that establishes the clear point the service committee is not practicing the Seventh Tradition, followed be stating valid reason(s) the basket is being passed.

Ken, if nothing else, we can say it's certainly not a customary practice to observe the Seventh Tradition during a service committee meeting, and the Seventh Tradition is for the groups, who in turn support the service structure. Ultimately, the service body will determine whether passing the basket is appropriate or not for their committee, of course taking into consideration whatever information is provided here, and other pertinent information that's motivating the service committee.

If you have any questions or need further assistance, please don't hesitate to contact us. Until then, we send you our best wishes in your ongoing recovery and in all of your service efforts to carry the message to the addict who still suffers.
