GSMANA OUTREACH REPORT September 28, 2008

Hello family,

The Outreach Subcommittee met twice this past month.

September 20th, 2008 - Outreach Subcommittee Meeting

The first meeting was on September 20th. We met at Morningside Park at 11:30 am. The mood was as bright as the sun that fine morning. We had 7 people from 5 different home groups, and were excited to be meeting for the second time. We began in usual fashion with hugs, smiles, laughter, and prayer. After that, it was on to the literature. We decided, as a subcommittee, that after we read the 12 Traditions and 12 Concepts at each meeting, we will read the corresponding concept of the month – and discuss it.

So, we read the ninth concept. And discussed it. We were reminded that it is often the lone voice in Narcotics Anonymous that can save us from a misinformed decision, and that it is important for us as individuals, groups, and service committees to seek out that lone voice. We were also reminded to "frankly speak our mind in discussions of service issues, even when most other members think differently" (GLS 13). Above all, we were reminded that each of us has an equal voice in NA.

Then we read two pages of the Outreach Resource Information handbook, as well as the preface. The sections were titled, "Preface," "Introduction," and "Outreach" (which is a basic overview of what outreach is). You may be asking yourself, why only two pages and the preface? The truth is that this is a slow process, and, as stated last month, we want to make sure that everybody that shows up has a good understanding what Outreach is. The meeting lasted about an hour and a half, which was just in time to beat the traffic on our way out.

September 27th, 2008 – Group Booklet Learning Day

The group booklet learning day was held yesterday, September 27th, 2008 from 11am-5pm. There were 14 members of Narcotics Anonymous there, representing 6 homegroups and 2 areas. Nine of us were from the GSMANA, whereas five were from the Chattanooga Area. Of the six homegroups represented, three were from this area and the other three were from Chattanooga. The two members of the Volunteer Regional Outreach

Subcommittee facilitated (facilitate = to make easier) the learning day.

We began with hugs, laughter, and prayer. Then we read the Traditions, Concepts, the Purpose of Outreach, and the Purpose of Workshops & Learning Days. Afterwards, the facilitators introduced themselves. They made sure to communicate that they were simply equal members of NA, nothing more – nothing less.

Before we got to the actual Group Booklet, we read and discussed tradition three, concept eight, the twelfth step, the first tradition, and the fifth tradition. As stated by one of the facilitators, "you have to set the table before you can eat on it." There was a hefty amount of discussion regarding each of the readings. The discussion was mainly focused on the spiritual principles of Integrity, Responsibility, Unity, Anonymity, and Commitment.

Lunch Break.

After lunch, we began reading and discussing the Group Booklet. We made good progress, noting the traditions that corresponded with the six points of a group, reading the sections titled, "What is a 'home group," "Who can be a member," "What are 'open' and 'closed' meetings," "Where can we hold NA meetings," "How can our group support other NA services," and "How can our group solve its problems," respectively.

The discussion was honest, open, vibrant, and vulnerable. It was suggested at the beginning of the day that how good the learning day was going to be directly related to how much the members present participated themselves. The day did not consist of two facilitators simply telling everyone what to do or think – it was a day of sharing and caring by everyone present.

The facilitators were available for questions or comments after the day was over. Their commitment to NA was visible. We will be sure to thank the VROS for taking their Saturday to spend with us here in the GSMANA. (attached is the agenda from the learning day)
