A motion was brought to the floor two cycles ago and was sent to Policy & Procedures to see how it would affect the guidelines. It was amended at the last RSC and was voted to be tabled until next cycle. However, we wanted to bring it back to the groups for discussion:

Motion by: Craig G from: PR Chair Second: Julius H. from: MTA

Motion reads:

To change article XII, Section 12C from-

C. Six thousand dollars seed money for the upcoming convention committee

To-

Article XII, Section 12C. To provide the VRC subcommittee an annual operating budget of

\$20,000. The VRC subcommittee can make a withdrawal from that budget to open up their bank account but the remaining funds can be accessed as necessary.

Intent:

To provide funding for a subcommittee of the VRSC without relying on the subcommittee to put on fundraisers. If we do not require H&I, Outreach, and PR to do fundraisers to provide for their budgets, it doesn't seem practical to require VRC to do fundraisers to provide their service.

Questions/comments from Floor:

Discussion only-seeking direction

- This will affect the guidelines: Article XII, Section 13, Volunteer Regional Convention Disbursement of Funds
- Would there still be fundraisers to offset the funds?
- It doesn't say that we can't do fundraisers
- VRC should not rely on fundraisers to fund the party
- PR, H&I, Outreach don't have to rely on fundraisers to fulfill their services
- An amendment will be made to the motion (listed above)

- Second withdrawn, new second added to the motion
- Maybe we should send this to our groups and talk about it again in May
- This was about being flexible, if someone needed extra money then we could do that rather than be specific about how much money they can have on a specific date
- This is just a budget, if they don't use all of these funds, that's great... but if they need it, it would be available.
- Last Chattanooga VRC costed around \$8,000
- Last Nashville VRC costed around \$44,000
- If we don't come up with something, we will end up coming back to groups to ask about needed funds over and over.
- Input from groups so far:
- Spend the money
- We need more information
- With the rising costs of hotels etc., it would be great to increase
- It would be a great idea, just not the \$20,000
- Voted to table: 6,1,1,0
- Motion tabled until next cycle,
- Take motion back to discuss with groups with the new information/discussion above.
