The minutes were accepted with the said correction.

Treasure - She stated the cost of the regional inventory was \$1,169.60 and approximately \$1100.00

was spent on gas reimbursement. Monies in our prudent reserve had to be used to cover for today's expenses. She also said we will probably need the money from VRC to make up our prudent reserve.

This committee sent \$20,000.00 to NAWS in 2007 by taking the vote of a straw pole from the RCM's, therefore not considering the operating expenses of our VRC we may need to assist the VRC with funds due to the economy as registrations are down. You can see the regional minutes for the full treasure's report.

The treasure is letting us know our prudent reserve is in the red. Many areas are not financially supporting the region. We talked about the basket not supporting the region. You will have to see the treasures report to observe how much more funds we have going out then coming in. She request that we let our areas know that we need to try to let the funds flow. We also discussed to try to tighten our belts and find ways to cut cost. We discussed with our subcommittees to spend money more wisely and try to utilize our resources and work in partnership with each other and keep cost down. If we are not able to do this then we will be forced to cut budgets.

VOLUNTEER REGIONAL SERVICE COMMITTEE, INC. 10/5/2008 TREASURER NOTES REGARDING SALESIUSE TAX

I am not a tax attorney or CPA and this is only a recommendation based on my understanding after reading the tax code and speaking with a CPA.

AREA LITERATURE SALES/RESALE

1) The amount of purchases and sales has no bearing on the tax code. It does not matter if we are selling \$10.00 worth of literature or \$10,000 the rules are the same.

The operative word is "Resale".

2) Areas should register with the State of Tennessee as an Unincorporated Association of Individuals and collect and remit tax to the State on all items that are sold. For Forms go to

www.tennessee.gov/revenue

3) Registration should be simply as an Unincorporated Association of Individuals and NOT as a Non-Profit Exempt Organization since:

- Only 501(c)(3) organizations can obtain an Exemption Certificate.

There is no benefit to the Areas in becoming a 501(c)(3) as we would still be equally as responsible to the State for collecting & remitting sales/use tax based on the fact that literature sales are on going.

4) If your Area registers with the State, they will also need to file an 1120 Tax with the IRS annually.

Federal ID Nos. for most Areas are already in place.

No Federal Tax should be due since Area pass on their profits/ net income (amounts over their prudent reserve) to the Region, who is a qualified 501(c)(3).

GROUP PURCHASES OF LITERATURE

Groups should be okay in buying Literature from the World or other Regions so long as they do not resale. In other words, Groups could purchase literature for its own use or to give away.

Most Groups purchase literature to give way, i.e. pamphlets, etc.

Books could have a suggested donation but should NOT be

required.

Mid West – Much discussion on tax issue. Area is taking responsibility of paying taxes, has tax ID number. No lit being sold at meetings – all is free. Area will be paying for literature.

GSMANA – Group Booklet Learning Day went well and had good participation.

Formed a new Out Reach Committee which is functioning well.

Our regional guidelines state, if a subcommittee chair person is absent for 2 or more consecutive meetings, he can be removed from office. I say this because the regional Out Reach chair person has not be attending and no one has spoken with him. A couple of trusted servants will go by his house and check on him. In the meantime Zach will be the interim Out Reach chair.

H&I - Jason

Learning day for Central Tennessee was a success.

Greater Nashville Metro had a book drive.

GSMANA panel coordinators were formed for presentations. They are focusing on jail meetings as well as other groups.

Five areas met on Saturday and shared their concerns and solutions regarding forming a news letter with the help of the newsletter hand book formed from WSO.

H&I is asking for \$200.00 worth of literature basic text's and white booklets, etc. Talk getting a rubberstamp with regional answering line number and web site address for meeting information. They want to stamp all their literature with this as well as all other areas to have their own stamp also. This will be a cost of \$30.00 per stamp. He requested the region pay for the cost, however after our Discussion on the lack of funds the region has decided to put his request on hold and will return with alternatives to this committee.

I want to mention that a letter was sent from the Band of Brotherhoods which is a group of prisoners looking for meeting schedules.

Out Reach - Zack

GSMANA had a guide to local services learning day. On September there was a Concept workshop in the Mountain area. Studied Concept 7-12.

VRC Convention Report – Pete F.

They need coffee and coffee supplies donated for the event. Please encourage. Please encourage all to register. All donations are down from last year. The balance so far is \$4,381.00. Please promote the convention and help it to be a success.

OLD BUSINESS

Sales tax – There was much discussion on this issue. Nashville groups order their own literature and have no problems. Literature is tax free if you give it away and order less than \$4800.00 per year. You must register with the IRS and pay taxes if your order is greater than \$4800.00 even if you do give it away.

<u>We need to clearly understand</u> if we purchase literature for the purpose of resale, we must pay taxes on it regardless of how much or how little we order.

If our area gets a tax exempt number and insist on selling it to the groups, then the area must pay taxes on the literature. That requires the area secretary to pay taxes quarterly, or every six months. Our special worker (CPA) will let him know how often he needs to pay it. The region is exempt because they do not sell literature. They have their own tax exempt number for buying

room time at VRC. H&I, PI and Out Reach literature should be free from taxes unless over \$4800.00 because they give theirs away.

The groups must not say they are selling literature, they must donate it to addicts who want it. Do not keep any records on literature sales, put it all in the basket, keeping it all under basket funds. The key word is re-sell. We do not re-sell literature!

I strongly encourage the groups to order their own literature, thereby removing this problem from the area service committee. If the area wants to provide literature they will need to pay 9.1% taxes, get a federal tax number and file a sales on tax report.

I noticed in Holly's report, nothing we mentioned about the \$4,800.00 limit of literature in paying taxes. I will verify this at the next Regional report and report it at our next area report.

Comment from VRSC H&I Chair — We will wait until money is available to purchase the H&T stamp that we were requesting.

Comment form VRSC PT Chair - We are only requesting the money for one presentation board which is \$314.00.

OUTREACH REPORT OCTOBER 27, 2008

This area's Outreach Subcommittee met twice this past month. The first meeting was at Carl Cowan Park on October 11^{th} . I was unable to attend this meeting. There were four people present at the meeting, and the discussion was heavily centered on explaining what Outreach is to a new member.

We also met earlier today. There were nine people from four different homegroups present. After beginning in usual fashion, we read and discussed the Tenth Concept. Afterwards, we read and discussed Chapter 12 of the PR Handbook, titled "Fellowship Development." It was strikingly similar to the Outreach Resource Information booklet that we read in September. The flow of the chapter was focused and helpful; it began with principles that applied to fellowship development (such as unity and attraction), planning and preparing for fellowship development services (such as coordinating services, approaches, and obstacles and solutions), putting the plan into action (such as communication, visiting groups, workshops and learning days, orientations, budgeting), and a 28

section on reaching incarcerated members.

We had enough time to fully discuss the content and intent of the chapter, as most of it was a review from what we have gone over in previous meetings. That is not to say, however, that this was a waste of time. We have a better understanding of how to serve our fellowship as a result of this chapter.

Our next meeting will be Sunday, November 16th at 9am. We will review everything we have read thus far, and use that information to develop a workable set of guidelines that will be effective for serving this area. Our plan is to review several different sets of guidelines that are being used in various other areas and regions, and tailoring them to the needs of our area. We hope to submit a set of guidelines for approval in either December or January.

Once again, our next meeting will be Sunday, November 16th at 9am. It will be here at the Square Dance Inc building. We welcome everyone to be a part of this process!
