Letter from Chris B:

"It's with a heavy heart that I'm sending you this today. It was never my intention to leave this commitment when I took it on, but I don't think I knew what I was signing up for. Not in this commitment, but in the other areas of my life. I don't think I realized how full my life was about to become and how hard finding a balance post pandemic would be for the way I operated in service. I don't think I understood just how full my life would get when my lost dreams came not only back to life but reached a level of fruition of sorts, with no end in sight. I think that I've done and am doing the subcommittee a great disservice by staying in past my expiration date anyways. For months and months, almost the entire time I became chair after vice chair, I have not had space or time to chair this Committee, I have done so anyways, but I have done the bare minimum and maybe a little less. I honestly believe anyone else would be a better option for representation and I believe someone new could possibly give this position the attention it adamantly demands. I have been drained of my willingness to give my all to it, and in that way have done a disservice. I heavily regret having to send my resignation this way, as If breaking up through text or a dear John letter, but even this is a good enough example of why I'm not the best choice to lead this subcommittee any longer. It has been a pleasure serving this subcommittee over the last three years of my recovery and I suspect my involvement isn't completely over by any means, but for myself, my family, and most importantly my own recovery and spirit, I have to step down. This isn't a choice I made on a whim or with a light heart, and I have been trying to avoid it for a while, but I don't have it in me to be on this side of it.

New Business:

Rachel S for Area Secretary. Has a sponsor, 6 years clean, works steps, has sponsees, has willingness, typing skills, Word experience. Was previous GSR of Noon 30, secretary of ROR.

Motion made, 2nd by Noon 30

James M for H&I Chair. Previous treasurer of Area, vice chair of Area, has a sponsor, works steps. Has been a panel leader in H&I and has H&I experience.

Motion made by Noon30

Change KANA to a 501C3 non-profit.

Discussion is as followed:

KANA is breaking the law by not reporting as a non-profit entity. Joe S provided the following information:

"Upon working to prepare to facilitate the transfer, I understand the Area is not a legal entity and therefore does not have a federal tax ID number i.e. Employee Identification Number (EIN), and the Area's checking account is currently tied to an individual social security number (SSN). This goes against NA guidelines see https://m.na.org/?ID=bulletins-bull32. This clearly states we should not use personal SSN for NA business. The primary reason for this is because the individual who supplies their SSN could be held liable to pay tax on the proceeds the KANA

Area receives in donations. Even if one can prove they are not liable, the cost of defending an IRS audit can be costly. Groups can file for an EIN and not be required to file tax returns or establish a legal entity if their donations do not exceed \$5,000 a year. KANA far exceeds this \$5,000 annual cap in donations.

Being a responsible productive member of society, I do not want to be exposed to potential tax liabilities and it is my strong recommendation that KANA establish itself as a Non-Profit entity (501(c) 3) just as the Volunteer Region of NA has done. Blake did propose this in the past, yet it was rejected by the Area.

If KANA does not do this, I believe we will have problems finding responsible treasures who would expose themselves to this liability. I know I am not willing to use my SSN to open any KANA checking accounts nor can I be complicit in avoiding statutory IRS and Tennessee State tax reporting requirements.

My understanding as to the process and cost to establish a non-profit entity in Tennessee are as follows. Please note I am not a Tax Professional or a lawyer. <u>The area should seek professional</u> advice before starting this process.

- 1. Form a nonprofit corporation in the State of Tennessee, Fee \$100
- 2. Apply for EIN Number, No cost
- 3. Apply to IRS for nonprofit status Form 1023-EZ \$200 professional fee, \$275 filing fee
- 4. State Nonprofit Registration, No cost
- 5. Ongoing requirements and costs
 - a. Tennessee State annual filing fee of \$5 for nonprofits
 - b. Annual Tax return, IRS Form 990-N \$300 professional fees

In closing, I request the area to please approve the money to spend to establish KANA as a nonprofit and a standing annual approved budget of \$5 State filing fee and tax prep cost of \$300 for IRS Form 990-N. If approved, we will need to decide on a name. e.g. Knoxville Area of Narcotics Anonymous, Inc. or Knoxville Area of NA, Inc or a name of the area's choosing.

Joe S is willing to put his own name as a registered agent if we change to a 501C3. We will pay no sales tax on purchases. We may want to seek professional advice on the matter. P&P Chair will add info on the subject into guidelines after an ADHOK committee comes up with them, such as who is responsible for filing the taxes each year. TAKE BACK TO GROUPS.
